**Subject of the Disclosure**

Notices from Philippine Amusement and Gaming Corporation (PAGCOR) recalling the revocation of the licenses to operate eBingo of AB Leisure Exponent, Inc. (ABLE) and Subsidiaries.

**Background/Description of the Disclosure**

AB Leisure Exponent, Inc. ("ABLE"), a wholly owned subsidiary of Leisure & Resorts World Corporation ("LRWC") on 24 September 2016 received via email, notices from Philippine Amusement and Gaming Corporation ("PAGCOR") of the approval by the PAGCOR's Board of Directors (BOD) to recall the revocation to operate eBingo. Twenty (20) eBingo sites have resumed its operations by virtue of the aforesaid approval.

The approval was based on the recommendation of PAGCOR's Gaming Licensing and Development Department (GLDD) and the legal opinion of its Corporate and Legal Services Department (CLSD) to honor the licenses of operators whose gaming sites are located inside malls, arcades and hotels and consider them exempted from distance requirements.

**Other Relevant Information**

The PAGCOR's BOD allowed the resumption of eBingo operations until the respective expiration of the licenses of the sites. PAGCOR's BOD, GLDD and CLSD are still in the process of studying whether they will permanently maintain the exemption of malls, arcades and hotels from the distance requirements.

Furthermore, licenses of the sites are renewable every two years.
