### Clarification of News Report

We reply to your request for clarification on a news article entitled "President orders all online gaming shut" posted in Manila Bulletin (Internet Edition) on December 23, 2016. The article reported in part that

"President Rodrigo Duterte has ordered the immediate shutdown of online gaming in the country.

'I am ordering the closure of all online gaming,' the President said in his speech after signing the General Appropriations Act of 2017 on Thursday. 'All of it. It has no use.' ...

Except for the television reports and online and newspaper articles relating to the pronouncement made by President Rodrigo Duterte, the company has no other information on the said pronouncement or order.
