Item 9. Other Events

In a meeting held today, January 14, 2011, AB Leisure Global, Inc. (ABLGI), a wholly-owned subsidiary of Leisure & Resorts World Corporation (LRWC), has been formally engaged by Belle Corporation through its subsidiary, Premium Leisure and Amusement, Inc. (PLAI), to act as operator and manager of its casino under a license issued by Philippine Amusement and Gaming Corporation (PAGCOR).

PLAI is a member of a consortium, which was granted a Provisional License by PAGCOR to establish and operate a casino to be located within the Manila Bay Reclamation Area.

As operator and manager of the casino, ABLGI shall exercise supervision, direction, and responsibility for the operation of the casino operations in behalf of PLAI pursuant to the Provisional License issued by PAGCOR.
