Notices from Philippine Amusement and Gaming Corporation (PAGCOR) for Electronic Games of Total Gamezone Xtreme, Inc.

**Background/Description of the Disclosure**

Total Gamezone Xtreme, Inc. ("TGXI"), a wholly owned subsidiary of Leisure & Resorts World Corporation ("LRWC") received notices today from Philippine Amusement and Gaming Corporation ("PAGCOR") informing that the PAGCOR's Board of Directors issued an order to immediately cease the operations of its Electronic Games at its Seventeen (17) sites due to non-compliance with the distance restriction guidelines under Section 2 of Regulation 3 of the Gaming Site Regulatory Manual (GSRM) for Electronic Games version 2.0.

**Other Relevant Information**

LRWC will send a letter of reconsideration to PAGCOR. Should reconsideration be not given, we will transfer the Electronic Games operations at said sites and transfer the same to compliant locations.
