Clarification of News Report

We reply to your request for clarification and/or confirmation on a news article under Biz Buzz column entitled "LR buy-in" published in the December 21, 2018 issue of the Philippine Daily Inquirer. The article reported in part that:

"While many stock pundits have gone on early holiday break, there has been some excitement from gaming firm Leisure and Resorts World Corp. (LR) of late. Yesterday, it was the most actively traded company at the stock market and its share prices surged by 5.03 percent in anticipation of an upcoming premium-to-market private placement.

We heard that a foreign gaming firm—based somewhere in Asia – is buying into the company and is bullish on LR's gaming operations in Cagayan Valley.
